SHEETECH SA SOCIAL CORPORATE INVESTMENT PROJECT

Sheetech SA was accredited on the 2nd May 2007 by Merseta to conduct training in the fields of Welding Application & Practice and Engineering Fabrication NQF Level 2 – 4 as well as NQF level 1 and CNC Machining.

In 2008 we undertook a Merseta Skills Programme Training with eight learners from the V.N. Naik School for the deaf. We were thereafter invited by Merseta to be the Guest of Honour at a Merseta function.

In 2010, Sheetech had the privilege of being awarded the tender to facilitate the training of 50 learners under the Merseta PWD Project which began in March 2010 and ended in March 2011. Thereafter these 50 learners were a three month employment contract with their respective lead employers. Upon completion of this contract the learners will then progressed to the next level of training which started mid July 2011.

Currently the learners are registered on NQF Level 1 and Engineering Fabrication (Boiler making) NQF Level 2 and NQF Level 3. The current learners will complete their learner-ship in July 2012. The Education and training division has developed a strong relationship with the deaf community particularly with:

2. A BRIEF HISTORY

3. PRODUCTION CAPABILITIES

3.1 PRODUCTION AREA

The production area comprises of two separate buildings dedicated purposefully for fabrication:

- Sheet Metal Fabrication: A total area of 1396 square meters.
- Assembly Area: A total of 450 square meters.
- Administration and Programming: A total area of 250 square meters.
- Sheetech SA Education and Training Division Training Workshop Facility and classroom.

- The ever-increasing scope and upgrade of the company called for more production space. In keeping with the development of the company we acquired the premises to facilitate the new projects.
- Production and Assembly Area: A total area of 2975 square meters. We began production in Mid April 2012.



3.2 <u>HUMAN RESOURCES</u>

Sheetech S.A currently employs a staff of 60 people with and additional compliment of 5 temporary staff. The staff is built around a management core with over 130 years experience between them. Further there is an assembly of skilled, competent senior staff who has worked together as a team for over 15 years at various previous companies.

Due to the experience and continuous training of our staff at Sheetech, we boast a multi-skilled workforce with a large number being able to perform any operation in fabricating sheet metal.

We currently operate a single shift 40 hour week, with the capability to operate a nightshift should it be required. This provides Sheetech SA with the capabilities to meet customer's delivery needs timeously.

3.3 MACHINERY and EQUIPEMENT

Sheetech SA has two premises in Queensmead Industrial Area which are used as:

Fabrication Shop:

- 2 Laser Cutting Machines
- 3 Guillotine Cutting Machines
- 4 CNC Punching Machines
- 15 CNC/Brake Press Bending Machines
- Welding (CO², Argon, Spot, Arc)
- Fettling Station
- Deburring Machine

The material gauges which can be cut, punched or laser cut range from 0.5mm to 10mm on mild steel and up to 6mm for stainless steel. The bending machines range from 60 to 400 tons. Material with a thickness of up to 10mm and length of up to 5 meters can be bent.

Press-shop:

Sheetech SA has 22 Press machines with capacity of between 10 tons and 100 tons. The multi-functional capability of our presses allows a large number of operations to be performed, hence enhancing Sheetech's capability to provide a wide variety of press work solutions.


